Clinical Training/Education Resources available on-line:

The UK Critical Care Nursing Alliance have published guidance on induction for non-critical care staff asked to work in critical care settings during the Covid-19 outbreak. This gives clear information regarding how to support these individuals to deliver care while maintaining patient safety. The guidance can be found here. Many Trusts are already delivering or planning to deliver up-skilling training, especially for those who have worked recently within a critical care setting, however to ensure that there is adequate provision and extend the offer of training for those from a non-critical care background we are planning to work with education providers to ensure that this can be delivered in a timely manner to up-skill staff to be able to respond quickly to surge.
