New Trainees and working bank holidays

We have received queries from host organisations about the contractual position of trainees working on the forthcoming bank holidays (Good Friday and Easter Monday), when many host organisations have cancelled leave.

In line with the 2016 junior doctor contract, a junior doctor who in the course of their duty is required to be present in the Trust (or other place of work) at any time (from 00.01 to 23.59) on a public holiday, or who is rostered to be on call on a public holiday, will be entitled to a standard working day off in lieu.
